(5) 本人为非中国籍公民，确认不具有中华人民共和国国籍，持有有效的非中国普通护照。本人已知悉并理解《中华人民共和国国籍法》相关规定。本人保证本人向学校提交的所有关于国籍身份的文件及护照信息均真实准确。本人知悉并同意，北京外国语大学开展的国籍资格审核属于外国人来华留学国籍身份的预审环节，最终审核结果以中国公安机关出入境管理部门的国籍认定结论为准。未能通过者，视为自动丧失北外入学资格及学籍。由此所引起的一切法律、行政及经济后果，均由本人独立承担。

I hereby solemnly declare, undertake, and agree to all the following terms:

1. All information and materials provided are factually true and correct. I understand that I may be subject to a range of possible disciplinary actions, including rejection of application, admission revocation or expulsion, if the information I've certified is false.

2. I have never committed any crime and have no criminal record to date. During my stay in China, I understand that I am obligated to comply with the laws and regulations of the Chinese government. I will not participate in any activities that are detrimental to social order in China or incompatible with my status as a student

3. During my study in China, I am obligated to understand and shall observe the rules and regulations of the university, will concentrate on my studies and researches and will follow the teaching programs provided by the university.

4. I promise to obey the Anti-Drug Law of People's Republic of China during my study and stay in China. I will take an active part in anti-drug education organized by the university. I will not take drugs, manufacture drugs and engage in drug trafficking. Under Chinese law, narcotic drugs and psychotropic substances subject to state control include, but are not limited to, cannabis, opium, heroin, morphine, cocaine, methamphetamine, ecstasy, pethidine, caffeine, and khat (*Catha edulis*). All such substances are strictly regulated. If I involve myself in any form of illegal act, I understand I will be punished in accordance to the law, and will be expelled according to Beijing Foreign Studies University Administrative Rules on International Students.

5. I am a non-Chinese citizen, confirming that I do not hold the nationality of the People's Republic of China, and I hold a valid non-Chinese ordinary passport. I have acknowledged and understood the relevant provisions of the Nationality Law of the People's Republic of China (PRC). I hereby warrant that all materials concerning my nationality and passport information provided to the University are true, correct, and complete. I acknowledge and agree that the nationality eligibility review conducted by Beijing Foreign Studies University constitutes a preliminary review for nationality and identity verification in relation to foreign students studying in China, and that the final determination shall be subject to the nationality determination made by the Exit and Entry Administration authorities of the Chinese public security organs. If I am found not to have passed the nationality eligibility review, I shall be deemed to have automatically forfeited my enrollment eligibility and student status at BFSU. Any and all legal, administrative, and economic consequences arising from any such violation or non-compliance shall be borne solely by myself.
